According to the John Burton Foundation, most current and former foster youth cannot afford to put themselves through college and have no one to help contribute to their education. Accessing financial aid gives youth an opportunity for a better educational outcome.

IMPORTANT DATES

This is the most important deadline date for Cal Grants. Be sure to submit the FAFSA and verified Cal Grant G.P.A. by the March 2 application deadline.

9/2 If attending a California community college in the fall and missed the March 2 deadline, submit the application by September 2. A limited number of awards are available for those applying in the fall, so be sure to meet the March 2 deadline.



RECENT CHANGES

Although the FAFSA/Dream Act and Chafee applications were available earlier than previous years, October 1, the priority deadline still remains March 2.

THE PROCESS



Complete the FAFSA (Free Application for Federal Student Aid): www.fafsa.gov

If an undocumented, an AB540 or DACA student, complete the Dream Act: www.dream.csac.ca.gov

Complete File Verification: provide college with the "Foster Youth Verification" letter from the county. Students may obtain a letter by contacting the ILP social worker of the day at (714) 704-8000. Letters are provided by the jurisdiction county. For example, LA dependents must contact LA County's ILP.

NOTE: Foster youth are considered "Independent Students" if they meet the following criteria: "orphan or ward/ dependent of the court or foster care at least one day after age 13."

Immunizations and Preteens

reteen Vaccine Week (PVW) is a statewide campaign celebrated yearly during the second week in February. In 2017, it will be February 8th through the 12th. PVW promotes the importance of immunizations and highlights preteen doctor visits as the opportunity to receive vaccines that protect teenagers from serious but preventable diseases.

Getting preteens immunized on time is one of the best ways to keep them healthy. Since 1994, PVW has served as a call to action for parents, caregivers and healthcare providers to ensure that preteens and teens are fully immunized against vaccine-preventable diseases. This year's theme, "HPV is Cancer Prevention", highlights how important the Human Papillomavirus (HPV) vaccine is for preteens and teens.

The Centers for Disease Control and Prevention recommend the following for preteens and teens in consultation with their primary care providers:

- All kids should get the flu vaccine every year, with three other vaccines starting from 11 to 12 years old.
- Older teens should be reminded by health care providers about the shots they have missed.
- Teens may also need a booster of a vaccine that needs more than one dose.

Overall, immunizations can help protect your kids as well as their friends, community and other family members around them, such as grandparents and babies who are too young to be immunized.

Did you know that as boys and girls get older they are at significant risk for some infections? As a result of the increased risk, routine office visits like appointments for camping or sports physicals provide opportunities to ask the doctor, nurse, pharmacist, or clinic about shots kids need that include the following:

TDAP

Tdap vaccine is a booster against tetanus, diphtheria and pertussis. Pertussis, or whooping cough, can keep kids out of school and activities for weeks. It can also be spread to babies, which can be especially dangerous.

FLU

Flu (influenza) is much more serious than the common cold. Even healthy, young people can get the flu and its effects can be serious. Children with chronic conditions like asthma or diabetes are especially at risk for pneumonia or even death. Due to the significance of potential health risks, the flu vaccine is recommended every year.

MENINGOCOCCAL

Meningococcal vaccine protects against meningococcal disease that's caused by certain bacteria that can spread to others during close or lengthy contact. Meningococcal disease is also the leading cause of bacterial meningitis (a serious infection surrounding the brain and spinal cord). Coughing, sneezing, kissing and sharing drinks are all ways the bacteria can be spread.

HPV

HPV vaccine protects girls and women against the types of Human Papillomavirus (HPV) that most commonly cause cervical cancer. The HPV vaccine can also help protect boys against genital warts and anal cancer.

Don't wait to vaccinate. Older children and adults who are vaccinated can help protect children who are too young to be fully immunized. Free Funding for Foster Youth

Foster and Community Youth Services

Orangewood Foundation offers Children's Trust Fund (CTF) Dependent Grants of up to \$250 per fiscal year (July 1 through June 30) per child for current Orange County foster youth ages 0 to 18. The grants are designed to support qualifying expenses such as:

- Camperships
- Yearbooks
- School pictures
- Prom/formal dances
- Graduation expenses
- Extracurricular activities (school/sports)
- Bicycle for work/school
- Up to an additional \$300 may be available for driving school

Education Travel Reimbursement

Keeping children's connections alive and strong.

oster children have the right to remain in the school in which they were last enrolled for the duration of the involvement of the Juvenile Court. This promotes educational continuity and is in the best interest of the children, including non minor dependents.

Reimbursement is provided to resource parents for transporting foster children to their school of origin over three miles each way. If the child has an individualized education plan (IEP) that specifies the district will provide transportation to school, the child is not eligible for the education travel reimbursement.

Resource parents are expected to transport the children to school activities such as sports or social events, as well as attending any required school meetings or conferences. Reimbursement is on a monthly basis and the distance is calculated utilizing Map-Quest.

The child's assigned social worker needs to submit a request for reimbursement (School of Origin Transportation Expense Form) to the child's assigned Eligibility Technician. Flat rates are paid based on the distance from the placement to the school of origin.

California Car Seat Law Changes

EFFECTIVE JANUARY 1, 2017



NEW ADDITION

Starting January 1, 2017, children under 2-years old must be rearfacing unless they weigh 40 pounds or more, or are 40 inches tall or more.

Children must be properly buckled in a car seat which is rear-facing until age 2

CURRENT LAW

Most children will outgrow an infant seat before age 1

- The next step is a convertible car seat.
- Rear-facing is 5 times safer than forward-facing.
- The American Academy of Pediatrics recommends that children ride rear-facing to the highest weight or height allowed by the car seat manufacturer.

Kaitlyn's Law

It's against California law to leave a child under the age of seven alone in the car without the supervision of a person at least 12 years old if:

- 1. The keys are in the ignition or the car is running, or
- 2. There is a significant risk to the child.

Children under age 8 must be buckled into a car seat or booster in the back seat.

Children age 8 or older, or who are 4'9" or taller, may use the vehicle seat belt if it fits properly with the lap belt low on the hips, touching the upper thighs, and the shoulder belt crossing the center of the chest. If children are not tall enough for proper belt fit, they must ride in a booster or car seat.

Everyone in the car must be properly buckled up.

FINES & PENALTIES

For each child under 16 who is not properly secured, parents (if in the car) or drivers can be fined more than \$500 and get a point on their driving records.

Keep your children safe. It's the law!
